# FELLOWSHIP OF CHRISTIAN ATHLETES (FCA) SCHOLARS STUDENTS

\$300 in Potential Grants for HQ Certificates & Courses<sup>1</sup>

#### **Start Your Journey!**

The <u>Hartwell Scholar Awards</u> outlined below are exclusive for *former* FCA students (high school graduates) who complete a minimum of 12 units of Hartwell Quest (HQ) <u>Smart Courses</u> or <u>certificates</u>. These grants work in conjunction with Option 1 in the <u>FCA Scholars</u> program for high school graduates and may not be stacked on top of other scholarships or discounted tuition rates, such as concurrent courses for high schoolers.

#### I. Hartwell Scholar Award eligibility for FORMER FCA students:

• **FORMER** FCA students may receive a \$150 Hartwell Scholar Award toward any <u>certificate</u> or 12-unit combination of <u>Smart Courses</u> after their FCA enrollment and high school graduation. An additional grant of \$150 may be awarded toward HQ certificates or courses totaling another 12 units, for a total of \$300.

Former FCA students may qualify for the above Hartwell Scholar Awards (totaling \$300) if they apply in writing by contacting HQ after their time with FCA to grant us permission to verify their involvement and good standing. These awards are not valid if the student has already received discounted tuition rates from HQ or other HQ grants and scholarships.

#### Please note the following:

o In the case of former FCA students planning to enroll with HQ: upon qualification, this award will be applied to your HQ tuition if you 1) pay for an entire certificate or block of 12-unit courses up front or 2) pay for individual classes until you reach the 12-unit threshold for the grant to be applied.

<sup>&</sup>lt;sup>1</sup> No HQ grant, scholarship, or award pays for any aspect of or participation in Title IV programs.

- o FCA Scholars students who choose option 1 can participate in these Hartwell Scholar Awards if they have not already received discounted tuition rates from HQ (such as concurrent course pricing for high schoolers) or other HQ grants and scholarships.
- o FCA Scholars students who choose option 2 can participate in the Max & Beverly Bowman Awards and help make Adopt A Scholar awards possible for others.
- o FCA Scholars award programs are listed on the <u>FCA Grants</u> page.
- o HQ awards and scholarship programs may not be "stacked" unless noted otherwise.
- o These awards do not apply to HQ courses that have discounted tuition rates or other grants or scholarships applied, such as concurrent classes for high schoolers, etc.
- o These awards are not valid if students have already received other HQ grants, scholarships, or discounted tuition rates.
- O Dismissal from FCA or HQ results in immediate disqualification for any HQ award. Students must be in good standing to qualify for HQ grants.
- No HQ grant, scholarship, or award pays for any aspect of or participation in Title IV programs. Grants are intended for ministry-related (non-academic) fellowship programs only.
- o HQ tuition, fees, and grants/scholarships are subject to change without notice.
